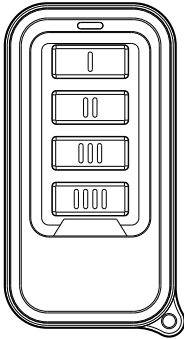


Remote Control Transmitter

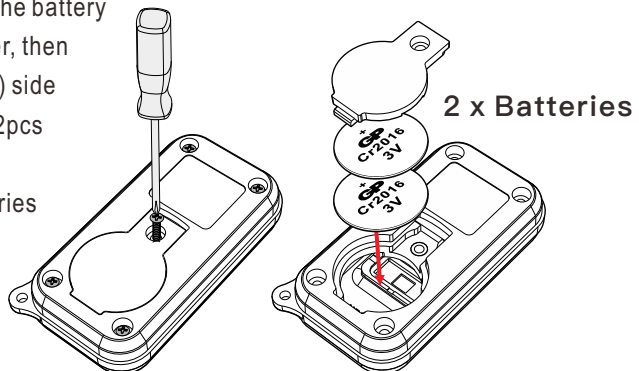

Programming

The programming method of the transmitter depends on the receiver. Please refer to the pairing method of the receiver.

How to Replace Battery

To replace the batteries, open the battery compartment with a screwdriver, then insert batteries with positive (+) side up. Replace the batteries with 2pcs of 3V CR2016 button batteries. Please dispose of the old batteries properly.
